TERMS: By signing this registration form, the registrant of the Temperament Certification™ training program ("Registrant") acknowledges and agrees to the terms stated herein. The Registrant named on this registration form will be participating in the Temperament Certification™ training program ("TCTP"). Participation in the TCTP does not guarantee that the Registrant will become Temperament Certified™. The Registrant must pass a certification exam, demonstrating competence in temperament theory and its various applications, and must agree to the Ethical Standards and Principles of Keirsej Temperament Theory. Approval of certification is determined at the sole discretion of the Temperament Certification™ instructors of AdvisorTeam.com, Inc ("AT"), and Synergy Leaders, LLC ("SL"). A Temperament Certified™ professional does not have the license to certify others as Temperament Certified™ professionals. The Temperament Certification™ is provided solely by AT, and SL in association with David M. Keirsej. As a Temperament Certified professional, an individual has the right to inform others of the training they received, and upon successful completion of the certification requirements, an individual has the right to inform others that they have become a Temperament Certified™ professional. These terms are subject to change at the sole discretion of AT and SL at any time for any reason. **Cancellation Policy:** All cancellations or transfers requested by the Registrant must be made in writing, at least 60 days prior to the confirmed scheduled date for the Temperament Certification Live Training session ("LT"). Payment may be applied to another LT date for a transfer fee (10% of total course fee). A transfer fee is charged each time a transfer is made. A maximum of two transfers is allowed, and the LT must take place within 12 months of the originally scheduled LT session date. In the event of cancellation initiated by the Registrant, where notice was received by AT or SL at least 60 days prior to the confirmed scheduled date for the Temperament Certification LT session, a refund will be issued minus a fee of 40% of the payment for the course tuition and minus the retail costs of all preparatory materials already utilized, accessed and/or already shipped.
